Invitation for Bids for procurement of Fabricated Steel Parts for Trail Bridges

1. Kanakasundari Rural Municipality Office of the Rural Municipal Executive Birat, Jumla invites Open Competitive Bidding from registered fabricators for supply of fabricated steel parts for following Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
2. Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years are eligible for the bidding. New fabricators may also apply in joint venture with an eligible fabricator having the required experience. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the minimum requirements.
3. Eligible Fabricator may obtain further information and inspect the bidding documents at Kanakasundari Rural Municipality Office of the Rural Municipal executive, Birat, Jumla or www.bolpatra.gov.np
4. Bidding documents must be purchased from www.bolpatra.gov.np/egp/ by eligible Fabricator, on submission of a written application and upon payment of a non-refundable fee for bid documents as mentioned in the following table, until the (last date of purchase of bidding document) 30th day from the first date of publication of this notice at Office hours.
5. Bids must be submitted through www.bolpatra.gov.np/egp/, on or before 12:00 noon on 2076/11/11. for Tender. Documents received after this deadline shall not be accepted.
6. Bids will be opened in the presence of Fabricator' representatives who choose to attend at Office of the Rural Municipal executive Kanakasundari Jumla, on 2076.11.11 at 13 Hours. Bids must be valid for a period of 90 days after bid opening and must be accompanied by bid security, which shall be valid for 30 days beyond the bid validity period.
